Please submit your application before July 1, 2018

Community Celebrations would like to invite you to join us as we celebrate Chataqua by parading through downtown Chewelah at 10:00 a.m. on the morning of Saturday July 14, 2018. In order to ensure that things go smoothly, we ask that you complete a registration form and release form and return it to the parade chairperson (contact info below).

Below is a list of a few items of interest that all parade participants should be aware of:

- The registration table is at Chewelah City Hall, 307 East Clay Avenue. We start registration at 7:30 a.m. Look for the registration table to receive your designated place in the parade. You will be given a number to place on your entry for judging. **Registration ends at 9:30 a.m. and no entries will be allowed after that time.**
- Be sure to share your information on your registration form so that we can get the word out about you, your community or your cause. Please be brief (we reserve the right to edit as needed).
- Due to insurance requirements, we must have the signed release form and proof of insurance before we can allow you to participate.
- Political candidates are welcome to participate. We do require a \$50 advertising fee. Only cash or checks are acceptable. Please make checks payable to Community Celebrations.
- If your entry includes horses or (other animals) we require that you provide your own pooper scooper. If you are going to Chataqua following the parade, please remember that there are no dogs allowed in the city park.
- Motorized vehicles **MUST** go slow! We love our audience members and do not want to have any accidents on Parade Day. All drivers must be 16 years or older and be able to provide a driver's license and proof of insurance.
- Self-powered entries must have a provision for towing in the event of a breakdown (It happens, we know!) and must comply with standard fire and mechanical safety codes. At least one operable fire extinguisher must be carried on your float. Please provide a copy of your Certificate of Insurance with your application.
- If your entry includes handouts, please remember to hand them out! **Do not throw them!** This includes candy, toys, promotional items, etc.
- The parade Awards ceremony will be from 12:30 p.m. to 1:00 p.m. at Center Stage in the Chewelah City Park.

Please take advantage of all the things that are offered at Chataqua while you are visiting: Arts and crafts, great food, entertainment, carnival rides and great Hospitality!

Release Form *(required)*

Instructions:

1. Applicants age 18 years or older, complete Part "A" only.
2. Applicants under age 18 must have a parent or guardian complete Parts "A" and "B".

Part "A" - Waiver & Release from Liability

In consideration of being permitted to enter for any purpose any RESTRICTED AREA (herein defined as the areas to which admission by general public spectators is prohibited), or being permitted to compete, officiate, observe, work for, or for any purpose participate in any way in the event, EACH OF THE UNDERSIGNED, for himself, his personal representatives, heirs, next of kin, acknowledges, agrees and represents that he has, or will immediately upon entering any of such restricted areas, and will continuously thereafter, inspect such restricted area or areas and all portions thereof which he enters and with which he comes in contact, and he does further warrant that he upon entering such restricted area and that his participation, if any, in the event constitutes an acknowledgement that he has inspected such restricted area and that he finds and accepts the same as being safe and reasonably suited for the purposes of his use and he further agrees and warrants that if, at any time, he is in or about restricted areas and he feels anything to be unsafe, he will immediately advise the officials of such and will leave the restricted area(s).

1. HEREBY RELEASES, WAIVES, DISCHARGES AND CONVENANTS NOT TO SUE the Chewelah Chataqua, Community Celebrations, the promoters, other participants, operators, officials, or any persons in a restricted area, sponsors, advertisers, owners and lessees of premises used to conduct the event and each of them, their officers and employees, all for the purpose herein referred to as "releasees" from all liability to the undersigned, his personal representatives, assigns, heirs, and next of kin for any and all damage, and any claim or demands therefor on account of injury of the person or property or resulting in death of the undersigned, whether caused by the negligence of the releasees or otherwise while the undersigned is in or upon the restricted area, and/or competing, officiating in, observing, or working for, or for any purposes participating in the event;
2. HEREBY AGREES TO INDEMNIFY AND SAVE AND HOLD HARMLESS the releasees and each of them from any loss, liability, damage, or cost they may incur due to the presence of the undersigned in or upon the restricted area or in any way competing, officiating, observing, or working for, or for any purpose participating in the event and whether caused by the negligence of the releasees or otherwise.
3. HEREBY ASSUMES FULL RESPONSIBILITY FOR AND RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE due to the negligence of releasees or otherwise while in or upon the restricted area and/or while competing, officiating, observing, or working for or for any purpose participating in the event.
4. EACH OF THE UNDERSIGNED expressly acknowledges and agrees that the activities at the event and in the restricted areas are dangerous and involve the risk of serious injury and/or death and/or property damage. EACH OF THE UNDERSIGNED further expressly agrees that the foregoing release, waiver, and indemnify agreement is intended to be as broad an inclusive as is permitted by the law of the Province or State in which the event is conducted and that if any portion thereof is held invalid, it is agreed that the balance notwithstanding, continues in full legal force and effect.

THE UNDERSIGNED HAS READ AND VOLUNTARILY SIGNS THE RELEASE AND WAIVER OF LIABILITY AND INDEMNIFY AGREEMENT, and further agrees to no oral representations, statements or inducement apart from the foregoing written have been made.

This waiver, release and indemnification, agreement specifically embraces each and every sanctioned, authorized or promoted by said releasees during the entire season it applies to each and every event, or activity hereinabove mentioned, and has the same effect as if executed after each and every activity or event in which the undersigned participates so that the parties herein intended to be released and indemnified shall be fully and effectively released and indemnified as to each and every event hereinabove described.
